<p>DEPARTMENT Provincial Hazard Assessment for Emergency Management:</p> <p>Implement a system to develop and maintain a provincial hazard assessment</p> <p>We recommend that the Department of Public Safety and Emergency Services implement a system to develop and maintain a provincial hazard assessment.</p> <p>Consequences of not taking action: Without an effective provincial hazard assessment system, the Government of Alberta may not be aware of its cumulative disaster risk exposure. It may not have the information necessary to identify its highest priority provincial hazards so that it can make informed, province-wide, evidence-based decisions. This could result in mitigation or preparedness efforts falling short. As a result, the Government of Alberta may not be investing in mitigation that meets provincial priorities. An ineffective provincial hazard assessment system could also result in the Government of Alberta incurring significant costs to respond to—and recover from—a disaster that it may have been able to mitigate or avoid.</p> <p>Incomplete or inadequate hazard assessments by ministries or local authorities may compromise the completeness and accuracy of the provincial hazard assessment system.</p>	<p>September 2020, p. 17</p>	<p>Not Ready for Assessment</p>
